We are not required to cut the grass as it is ERYCC's responsibility, but it was decided to continue to do so, and therefore we need to find a new contractor

10. **Planning:**
 - New house on land north of Peartree House has been refused by ERYCC

- Permission for new houses and other developments at Manor Farm was discussed, no objections to be raised (Planning permission subsequently withdrawn)
