- 4. Confirmation of Minutes of the last meeting: The Minutes were approved
- 5. Matters arising from the Minutes of the last meeting:
 - Knedlington Crossroads survey. As nothing has been heard since the last meeting, it
 was agreed to approach Ward Councillor David Howard for an update and to move
 the matter forward.
 - II. Granger Pond/The Paddock. ERYC have been approached for assistance in determining ownership of the strip of land fronting The Paddock development and Yorkshire Water have also been asked for any records of a drainage agreement on this piece of land.
 - III. D-Day 60th anniversary beacons; it was agreed to carry over this item to the next meeting for a decision on whether or not to participate.
 - IV. The location of the proposed food donation chest is still being looked into, with one proposal being St Helen's church.
 - V. All the remaining Hedgehog Highways have been donated to the village school.
